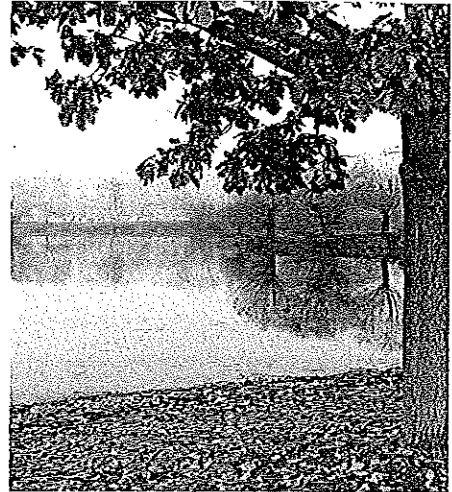


## VanBibber Lake POA News - April 2011

A Member seeking nomination must obtain a minimum of five (5) signatures from such Member's section nominating such Member for election."
