Shut Off Procedures

Due date of water/sewer bill is the 15th of each month.
By the 16th, if bill is not paid, penalties will be added.
By the 18th, if payment is not received, a shut off notice will be delivered to resident
By the 25th payment must be paid in full.
If payment is not received, by the 26th, water will be shut off.
Then resident would pay \$75.00 hook up fee, plus a \$50.00 water deposit, total of \$125.00.

Re-Connect Resolution

Whereas, The VanBibber Lake Conservancy Board of Directors, during the May 19, 2009 Board Meeting, moved to change our re-connect fee totals.

Resolution shall read as follows:

If resident fails to respond to the billing mailed requesting payment, their water will be shut off and the following fees will be charge for re-connect of water service.

There will be a \$75.00 hook up fee.
There will be a \$50.00 deposit on the water side.
Total amount of \$125.00 due plus water bill in full,.

SEASONAL DIS-CONNECT AND RE-CONNECT FEES REMAIN THE SAME. (\$75.00)

By the 16th, if bill is not paid, penalties will be added.


By the 18th, if payment is not received, a shut off notice will be delivered to resident.
